Rethinking CASE

You may recall that earlier this year, all CASE member eligible employees were asked to vote on whether to split the current bargaining unit or keep it as it is currently structured. Approximately 80% of those voting favored the split and so proposed legislation started its way through the state house and senate delegations. The Thursday before the end of the session, both chambers

approved the bill that separated the unit between those whose jobs require an MSDE certificate (the original CASE unit) and those "non-certificated" employees whose job does not. The bill was signed into law by the governor with an effective date for implementation of July 1, 2013. At least for the short term, it is the hope of the CASE staff that we will be able to continue to represent both units.

Joining CASEThis is the perfect time to become active in CASE as we must now begin to plan for how the new units will look. We will need everyone's help and support as we work through this process. CASE is planning to hold some discussion group sessions over the summer at various locations around the county to get member input on preferred options before we sit down with the Board of Education to finalize the two units and their respective composition. I would encourage every eligible employee to come to one of these sessions. If you are unable to attend but have some thoughts about what you'd like to see, be sure to send them my way.
